Application for the rental of ITEA S.p.A affordable housing

For an easier compilation of the online application and getting all the useful information for the choice of the apartments, please read the notice published on the web page of the local authority where you are going to submit your application.

So you will know in detail how many and which apartments are available for your household, the characteristics of each apartment (floor area, number of rooms, type of heating, accessibility barriers, etc.), the floor plans and photographic documentation.

In addition, for the apartments available after a *do-it-yourself-renovation*, you will find the "Estimated Bill of Quantities" describing the works to be carried out and the "Financial Overview" indicating the maximum reimbursable expenditure. *Do-it-yourself-renovation apartments* are units that require maintenance works to be carried out by the tenant before moving in. The costs will then be reimbursed by ITEA.

If it is your first access to "Stanza del cittadino" with CIE or CPS/CNS you will be asked to indicate an email; this email will be used to send you notifications and reports.







Also check if the apartment requires work at your expense; in this case, ITEA will reimburse you for the costs (do-it-yourself-renovation apartments).

If there is at least one apartment, click on the "Avanti" button to continue.

If there aren't available apartments, you can't continue the submission of the application. You can read the following message "Attention! If at least one apartment is available, each one is presented with a summary sheet containing key information. The notice published on the web page of the local authority provides a complete description, including all the details, a cadastral map, and photos of the properties.







Selected apartments: preference order

Now the system shows you the list of apartments you have selected and asks you to indicate, in the appropriate field, the order of preference for the possible assignment proposal of one of them.



In the field:

- "In autorecupero (do-it-yourself-renovation)" you can read if the apartment is a do-it-yourself-renovation one or not.
- "Priorità per i residenti (Priority for families residing)": "Sì (Yes)" means that
 the apartment will be given as a priority to families residing in the
 municipality where it is located, provided that they have indicated this as
 their priority among their expressed preferences. The following examples
 help you to better understand this mechanism.

Example 1:

An available accommodation is located in Municipality X and has a priority assignment constraint for residents in the same municipality. The household resides in Municipality X.

Case 1 – The household chooses the accommodation as first preference:

Case 2 – The household chooses the accommodation as second preference or doesn't choose it:

in this case, it doesn't express the priority choice of the accommodation and effectively waives priority in the assignment proposal

Example 2:

Case 1 – The household chooses the accommodations as first and second preference:

Case 2 – The household chooses one accommodation as first preference and doesn't choose the other as second preference:

14. Reporting the need for affordable housing

If there is no apartment available for your household in the area of the local authority where you wish to submit your application, or if you have not found any apartment of interest to you, complete and submit the "Segnalazione del bisogno abitativo (Report of housing need)" by accessing the link Report of housing need

Log in using SPID, CIE, or CPS/CNS. To know the access method see <u>Chapter 1</u>. <u>Application submission procedures</u>.

Completing this form is very important. It enables the authorities to identify household housing needs and plan housing provisions effectively.

The form can only be completed once.

In the form, you can indicate up to five municipalities in the province where you would like to live. If you have no preference, select the option "In qualsiasi comune della Provincia (In any municipality in the Province)".
